# MESSAGE FROM ANDRE SOLYMOSI, GM BCVMC

On December 7<sup>th</sup> we circulated a message from our Chair, Derek Sturko, informing you of several key activities that the BC Vegetable Marketing Commission (Commission) has worked on over this past year, and notifying you of an updated Commission General Orders. A copy of this message has been posted on our webpage under 'News and Notices'.

Coming into effect on January 1, 2024, the Commission Consolidated General Orders of March 16, 2005 (as amended) is repealed, in its entirety, and replaced with the British Columbia Vegetable Marketing Commission General Orders of January 1, 2024. In addition, the Interim Order to Preserve the Orderly Marketing of Storage Crops Pending Further Review made by the Commission on November 18, 2019 is repealed.

### • 2024 COMMISSION ELECTIONS & APPOINTMENTS

One (1) independent member position is up for appointment in 2024 and two producer member positions (one (1) Storage Crop category and one (1) Greenhouse category) are up for election in 2024. Member terms are for three (3) years and commence on May 1<sup>st</sup>, 2024. Notices on both the election and appointment process will be distributed to stakeholders in January. We encourage Producers to let their name stand for nomination and take the opportunity to get involved as a member of the Commission. In the New Year we will continue to work towards ensuring regulations are responsive to the needs of the industry, clear and concise, and enhance the administrative efficiency of the Commission. # Keep those spuds clean!

#### DID YOU KNOW...

A Greenhouse is defined as "an enclosed structure where Regulated Product is grown."

This means that any structure, no matter how it is constructed, as long as it is "enclosed" is a Greenhouse. This is to ensure that the new developing technology of "Vertical Farming" and similar developing technologies are regulated to not cause market disruption to current production using traditional Greenhouses. This includes any area producing Regulated Product in a container or warehouse using these new technologies.

## WHO WE ARE:

The BCVMC is a Public Sector Organization (PSO) charged by the BC Government to administer and ensure compliance with the provisions of the Natural Products Marketing (BC) Act (NPMA) as it relates to regulated vegetables.
