Revised General Order & Task Force

As mentioned in our last newsletter, a General Order Task Force was set up to provide an opportunity for staff to get input from members of the industry as we develop policy and potential improvements to our General Order. The Task Force met in February, April, May and June, and is progressing well in its work. It is on track to wrap up this summer. A full industry consulation will be held in the fall to provide industry participants an opportunity to review the proposed changes and provide comments for consideration by the Commission.

BCVMC AGM & Townhall Session

Our 2025 Annual General Meeting was held on April 23rd at the Coast Tsawwassen Inn. There was a good turnout for the meeting in person and through our video conference link. Our new Chair, Wes Shoemaker, started the meeting with a review of 2024 highlights and the outlook for 2025. Gunta Vitins from the BC Farm Industry Review Board (BCFIRB), which oversees regulated marketing boards for the BC Ministry of Agriculture, addressed the meeting with some comments on the BCVMC's work and expressed her confidence that the BCVMC is moving forward in a positive direction.

A financial overview was provided by our Auditor, and that was followed by a presentation of our 2025 budget and strategic priorities. With a full complement of staff now in place, the Commission will focus its efforts to improve communication, engage in consultation with industry, and implement improvements to the regulatory framework. Compliance Administrator, shared a report that highlighted sustained growth in the Greenhouse sector and increases to planting acreage for Storage Crops.

Our 2024 BCVMC Election concluded with the reappointment of Paul Guichon as a Storage Crop Representative (by acclamation) and the appointment of Casey Houweling as the Greenhouse Representative (following a vote administered independently by BCCOMB). Wes Shoemaker announced the appointment of the Independent Members Daphne Stancil (to a 3-year term) and Craig Evans (reappointed for a 2-year term). Commissioners John Newell and Natalie Veles were thanked for their service to the Commission.

Following a very insightful presentation by BMO Economist Aaron Goertzen, a lively question and answer session was held in which collaboration and ongoing open communication was encouraged.

Normal Value Review

At the beginning of this year, the Commission submitted a request to the Canada Border Services Agency (CBSA) to review the "Normal Value" that is used to calculate anti-dumping duties for the importation of certain potatoes from the United States. This protection against the sale of American potatoes in Canada at prices below their cost of production has been in place since 1984, but the level used to calculate what constitutes the normal value of potatoes had not been updated since well before the period of very high inflation over the past several years. Over the past three months we were supporting the BC industry by preparing a case argument as to what fairly reflects the current cost of production. CBSA will now review submissions and make a determination as to whether the Normal Value will be updated.

Later this year, we will be establishing a working group to assist us in developing our submission in support of the continuation of the anti-dumping provisions on US potaces for use or consumption in BC that are due for review by the Canadian International Trade Tribunal (CITT) in 2026. We will be reaching out to members of the industry who have supported this work in the past. If you are interested in participating in this working group, please contact the Commission office.

Trade & Tariff Issues

Although trade and tariff talk has been slipping off the front page of newspapers lately due to other geopolitical turmoil, we are currently only a few weeks away from either an announcement of a new deal between Canada and the United States or back into a world of escalating tariffs and counter-tariffs. If you are struggling to keep pace with understanding the array of different relief programs, you might find the following regularly updated resources helpful:

2. Customs Notice 25-19 provides information on how to access the relief program for the countertariffs Canada put in place on March 4, 2025 (United States Surtax Order (2025-1)). The most likely aspect of this to be relevant is the HS Code categories related to food packaging materials. You can find this by searching for "Customs Notice 25-19".
